The challenges posed by the water companies are:

Leakage – we are going to have a national target of a 50% reduction in leakage by 2040. How could we achieve that? What technology is out there to help?

Smart metering – the technology is new and not yet perfect, but is clearly going to provide benefits. We want to introduce it at the optimal time such that we do it right first time with maximum benefit. When would you invest and with what form of smart metering?

Lead pipes - We will be replacing a number of customer side lead pipes in the next AMP. At present most of the new pipe to the customer's property is done via open trench. Current no dig solutions that we are aware of are not reliable and prone to issues. Are there any new no dig solutions to enable a cheaper, less destructive and reliable methods for replacing lead services.

Newly laid pipelines - How do we future proof our newly laid pipelines to enable easy leakage detection and possibly water quality monitoring. When new pipes are laid we need to ensure that we can easily detect leaks and if possible monitor simple water quality parameters, such as turbidity and chlorine.
